The net gain for the 3<sup>rd</sup> Quarter 2014 was \$42,414, an improvement of \$1,003,947 compared to the \$1,046,361 loss from the 3<sup>rd</sup> Quarter of 2013. Basic Earnings Gain/(Loss) per share for the 3<sup>rd</sup> Quarter 2014 were \$0.001. Fully diluted Earnings Gain/(Loss) per share for the 3<sup>rd</sup> Quarter of 2013.

For the 9 months ended 30 September 2014, revenue was \$2,129,371, compared to the revenue for the 9 months ended 30 September 2013 of \$803,769. Total operating expenses for the 9 months ended 30 September 2014 were \$4,059,422 and a loss of (\$2,313,346). Total operating expenses for the 9 months ended 30 September 2013 were \$4,246,720 and a loss of (\$3,442,951).
